About the Placement Organisation

The Mid Yorkshire Hospitals NHS Trust was formed in April 2002 when the former Pinderfields and Pontefract Hospitals NHS Trust and Dewsbury Health Care NHS Trust merged together.

This is a large acute hospital Trust, serving the communities of Wakefield District and North Kirklees, which makes up around half a million people and also treats patients from surrounding areas too including South Leeds, North Yorkshire, Barnsley and Doncaster.

Most of the services are provided from three main hospital sites - Pinderfields General Hospital, Dewsbury and District Hospital and Pontefract General Infirmary. In addition, day case and outpatient services are provided from Clayton Hospital in Wakefield with some services provided at other facilities and clinics across the district.

Purpose of the Placement

This profile has been designed to give prospective trainees an outline of some of the potential areas of training. A personal skills training programme will be drawn up in the consultation with the trainee after induction to build on their personal strengths and address their individual development needs.

The trainee will carry out routine phlebotomy (blood collection) duties as set out in standard operating procedures. These duties will take place within the blood collecting room, on wards and at selected clinics and surgeries as required. The trainee will also be involved in associated clerical duties within the department

The trainee will undertake blood collection as required from patients attending the out patients' blood collection room and from in-patients. They will also train independently at external clinics, surgeries and health centres as required to collect blood samples. The trainee will:

- Provide a high quality and timely blood collection service to all users.
- Work in an efficient and cost-effective manner.
- Follow all departmental policies and procedures, including Trust and departmental health and safety procedures.

There is a possibility that trainee may be required to work flexibly between the hours of 8:00 am to 8:30 pm, Monday to Friday on a rota basis.

Work Skills Development

Clinical

- To collect blood samples by both venepuncture and capillary methods where appropriate, for laboratory testing. Patients will include inpatients and outpatients from the Trust and from General Practice and includes babies and young children where appropriate.
- To ensure that blood samples are placed in appropriate specimen containers as set out in instructions and to carry out clear and accurate labelling of these samples.
- To ensure that all samples are of acceptable quality taken from an appropriate vein and collected in sufficient quantity.
- To ensure that all samples are delivered promptly to the specimen collection point or to Pathology Specimen Reception as appropriate.
- To inform Phlebotomist Supervisor(s) of any operational problems that is encountered.
- To follow standard operating procedures, health and safety policies and procedures and Trust policies where applicable.
- To maintain a clean and tidy environment whilst collecting blood samples on wards or in surgeries.
- To maintain blood collecting trays/trolleys and work surfaces in the blood Collecting Room in a clean and tidy condition.
- To undertake 'Near Patient Testing' where appropriate (site dependant).

Communications

- To communicate with patients many of whom may have a barrier to understanding, in a friendly and helpful manner.
- To communicate with staff in general practice surgeries and Health Centres regarding stocks of equipment and service requirements as required.

Other

- To maintain the confidentiality of Trust and information and use such information only as authorised for specific purposes. Report any concerns about the use of such information to your senior manager.
- To undertake any other duties consistent with the grade as indicated by the chief Biomedical Scientist or his/her appointed representative.
